DOG WASTE CLEAN UP

PLEASE take a bag or scoop with you! After the February newsletter was sent out, the office received more complaints about this issue.

All dog owners must do their part after their dog. Dog waste is a to neighbors. Dog waste is one



of the top contributors to contamination of stormwater runoff, which has a significant impact on area streams and Lake Michigan.

Clean up after your dog and properly dispose of pet waste. The office has advised owners to call the non emergency number for the Wind Point police 262-639-3022 to ask that a ticket be issued to those that are violating the WMC rules and the VWP ordinance which is as follows:

Pet waste

In order to keep the Village clean for everyone, dog owners are required to pick up after their dogs when walking them. Please remember to bring a scooper, bag or other method for clean up when walking your pet.

In addition, all dog owners are required by state law to obtain an annual license by April 1 of each calendar year-a current rabies vaccination certificate from the veterinarian must be provided. Please find this form and info on the Village website.



ATTENTION OWNERS OF RENTAL PROPERTIES-ASAP

If your unit or home is a rental property, please send to the office a copy of your lease agreement and contact information for the resident. With the new bylaw in place, leases will "register" your unit/home as a rental as of 1/30/2023 and your unit will be grandfathered in as a rental until the unit/home changes ownership. If your rental is not registered and there are more than 5% of the units in your PSA rented then your unit may not be eligible as a rental going forward. In addition, the Village of Wind Point has a registration from that is required to be on file if your unit or home is a trental. Please check their website for this form and register accordingly.

WILD GARLIC MUSTARD

If you are so inclined, please start pulling wild garlic mustard as soon as you see it growing. The garlic mustard around your homes and in the common wooded areas is quite severe. The best way to control this obnoxious invasive weed is to pull it out. Pulling it in the spring while the ground is soft will be much easier to get the entire plant, including the root. Each plant can release hundreds of seeds when mature, and it spreads fast. After pulling, put it in a black plastic bag, labeled "GARLIC MUSTARD" and put it out with the garbage any Monday morning. **DO NOT LEAVE IT ALONG THE ROADSIDE**
