## BOARD MEETING







## **SNOW REMOVAL PROCESS**

Snow removal occurs in the **Patio, Village, Manor, Garden, and Prairie Meadows Homes** when snow accumulation on the ground reaches 2 inches or more. The private drives and courts will be opened on the first pass-through, so residents can drive to the main streets, whether it is still snowing or not. After the snow has stopped, the private drives, courts & driveways will be opened. Once that work is completed, mailbox stations, guest parking areas, and fire hydrants will be cleared, and any other detail work. **Note:** The Village of Wind Point plows Lake Meadow Dr, Campus Drive, and Deepwood Drive along with the Single Family Courts.
