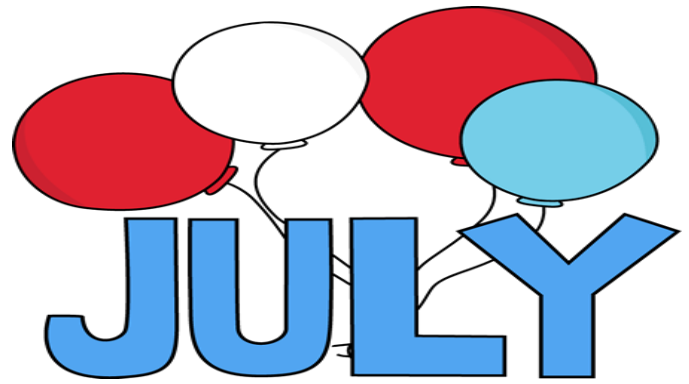

## **JOHN'S DISPOSAL SERVICE, INC.**

All trash must be in a secure and sanitary container and may be placed outside no earlier than 6:00 p.m. the night before scheduled pickup. Containers must be stored out of sight the same day following pickup. **Recycling collection and yard waste collection** is every other Monday unless the Monday is a holiday.

**The July recycling dates are Monday, July 7th, and 21st.**

## Pool Rules and Regulations

### Section 1. General Rules

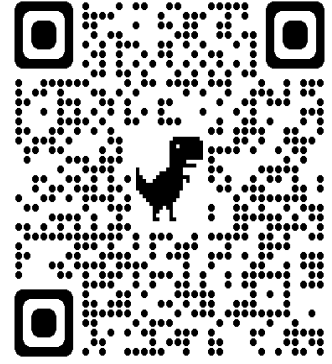
- (a). All persons using the pool and/or sunbathing must register upon entering the area through the gate and present their Wind Meadows identification card to the lifeguard.
- (b). The lifeguards on duty are under the direction of the Management Company Representative, and are in complete charge of the pool and the pool area at all times.
- (c). The lifeguards have authority and permission to refuse use of the pool to anyone who is unclean, who may have a contagious skin condition or are improperly attired.
- (d). Guests. A WMC member household may have up to six (6) guests who are not members of the WMC member's household without a reservation for a private party. All private parties must be reserved in advance with the Site Manager. If additional lifeguards are needed, a fee will be charged to the member.
- (e). **A child twelve (12) years of age and under is allowed in the pool area only if accompanied by a parent member or a qualified sitter. All sitters, including brothers and sisters appointed as sitters must be at least thirteen (13) years of age.**
- (f). **Sitters do not pay a pool fee. The lifeguards will report irresponsible sitters and appropriate action will be taken.**
- (g). Parents must insist that sitters identify themselves and their charges to the lifeguards at the pool when they enter.
- (h). All clothing changes or diaper changes must be done in the locker room and not on the pool deck.
- (i). Infants wearing swim diapers or clean *cloth* diapers covered by snugly fitting rubber pants or disposable diapers will be allowed in the pool.
- (j). The lifeguard must approve floating devices and toys. Their use should be limited to times when the pool is not crowded.
- (k). The Leisure Center is not responsible for lost or stolen articles. Lost and found items will be retained for claiming by the guards for a period of two weeks.
- (l). Food and beverages should be used with discretion, but not immediately adjacent to poolside. Litter must be promptly deposited in appropriate containers in the pool area or in the clubhouse.
- (m). The Management Company Representative at his/her/their discretion may schedule regular times for "adult-only" swims.
- (n). Loud or distracting music playing is prohibited. Headphones are recommended.
- (o). Saving lounge chairs for members or guests who have not yet arrived is not permitted.
- (p). No glass or ceramics are permitted within the pool area, on the pool deck or in the pool, including but not limited to glass bottles, dishes, bowls, pitchers, or tempered glass goggles.



**ALL EXTERIOR CHANGES MUST BE APPROVED BY THE ARCHITECTURAL REVIEW COMMITTEE !**

All exterior changes need prior approval from the ARC and WMC Board of Directors. This applies to **ALL** homes in Wind Meadows. These changes include, but are not limited to, changing the color of your single-family home or roof, satellite dish or solar installation, window or patio door changes, deck or patio modifications, replacement or changes to landscaping around your home as well as swing set/trampoline/playhouse additions, to name a few. Don't forget to share pictures of location of changes along with any other pictures that would be helpful to the committee. Board meetings are on the third Monday of every month. Requests are due 15 days prior to the Board meeting. After approval, it is the homeowner's responsibility to obtain any necessary building permits, etc. required by the Village of Wind Point. Thank you to all homeowners that follow the WMC Guidelines, Rules and Regulations.



**Please use Sevin Insect spray if you plantings show signs of beetle damage!**

Viburnum leaf beetle damage typically manifests as leaf skeletonization (only veins left) or complete defoliation, sometimes leading to branch dieback. Larvae and adults feed on the foliage, creating holes and gradually stripping away the leaf tissue. Over time, severe infestations can weaken the plant, potentially causing dieback and even death.



Pokeweed is a native plant in Wisconsin, but can be a problematic weed due to its potential for overabundance and the toxicity of all its parts. While its berries are attractive, they should not be eaten as they are poisonous. Pokeweed is often found in disturbed areas like woodlands, roadsides, and vacant lots.



**To get rid of pokeweed** in Wisconsin, a combination of methods is often necessary, especially for established infestations. Hand pulling or digging out young plants is effective, while herbicides like glyphosate or triclopyr can be used for mature plants. Regular mowing and cutting before flowering can also help prevent seed production.

## Fireworks Reminders from the Village of Wind Point

**Please note that fireworks that propel into the air or explode are prohibited in the Village. Fireworks and related toy items that stay on the ground are allowed, but loud noises (especially at night) may be considered a nuisance under Village ordinances.**

The illegal use of fireworks is a danger to you and your neighbors. Fireworks can cause significant injury when not handled properly. Additionally, according to the National Safety Council, fireworks start an average of 18,500 fires each year, including 1,300 structure fires and 300 vehicle fires. The noise from fireworks is especially difficult for some combat veterans and pets. For veterans with post-traumatic stress disorder (PTSD), the loud and unexpected noise from fireworks can be a source of stress and anxiety. Please be considerate of your neighbors.





## **WILD GARLIC MUSTARD**

Please start pulling as soon as you see it growing. The garlic mustard around your homes and in the common wooded areas is quite severe. The best way to control this obnoxious invasive weed is to pull it out. Pulling it in the spring while the ground is soft will be much easier to get the entire plant, root. Each plant can release hundreds of seeds when mature, and it spreads fast. After pulling, put it in a black plastic bag, labeled "GARLIC MUSTARD" and put it out with the garbage morning. **DO NOT LEAVE IT ALONG THE ROADSIDE UNBAGGED.**



## **ADA COMMITTEE NEEDS YOU**

Have you tried to get to the Leisure Center pool, only to realize that your unsteady gait wouldn't allow you to make it down the stairs? Do you have a child with a disability that has been unable to access the pool? Or have you owned a business and realized you needed it to be accessible to your customers and patrons, to be successful? If so, the ADA Committee needs you!

The HOA Board of Directors formed an ADA (Americans with Disabilities Act) Committee in 2024 to explore ways to make the Leisure Center ADA compliant. Four members currently serve on the committee: Marsha Connet, Elizabeth Olley, Carole Richard and Jill Sturino. The committee has been provided a survey and written report for accessibility of the Leisure Center, as a starting point to implement recommendations over time to remove barriers to access. We are looking for some additional volunteers who may have expertise or resources to help us achieve our goal to make the Leisure Center accessible for all residents and their guests. ## **2025 Lighthouse Tower Climb Dates**

## BRANCH COLLECTION

**Wind Point Public Works** collects branches from residents for disposal **starting** in 2025 on the **second Tuesday of April, June, August, and October**. Branch pick-up does not include leaves, weeds, and other yard waste.

**John's Disposal Service** will pick up securely bundled yard waste, including brush that is no more than 50lbs, or 4ft long, or 6in in total bundled diameter. This service is available **every other week beginning April 1, 2025 through the end of November**. For information about yard waste collection please [click here](#).

In order to provide this service efficiently, the following rules apply:

1. Branch collection is for tree maintenance (trimming branches) NOT tree removal. Property owners who have landscapers or other individuals cut down trees on their property are responsible for branch disposal.
2. Branches should not exceed 4 inches in diameter. Branches should be kept at their original length and not cut into smaller pieces.
3. Branches should be placed by the road in small, reasonably uniform piles. Piles should not exceed 4 feet in height and 4 feet in width. Pile branches with the cut end toward the road, all in the same direction.
4. Branch piles should be set out near the edge of the road away from mailboxes or other obstructions. Piles should be set out no earlier than the Saturday before collection day (72 hours). Piles set out too early or late can be tagged with a notice indicating the resident has 48 hours to remove the items. Tags will be noted with the date and time that they were placed. If branches are not removed within 48 hours as stated on the tag, a special collection will be arranged with Johns Disposal and the resident will be charged.
5. Stumps, vines, root balls, roots, rocks, brush, rubbish, construction material or metal will not be collected.
6. If collection cannot be completed on a given day, the remainder of the route will be completed the next work day (s). To maintain scheduled operations, we cannot "backtrack" to collect branches set out late.
7. Up to 15 minutes will be spent per property on collecting and chipping.

Any piles that exceed this time will be tagged and the owner will have the option to remove the piles or have them collected for a fee.

### Storm-related Branch Collections

In the event of significant, widespread storm damage in the Village, the Village President or Village Administrator may declare an emergency storm-related branch collection.
